IMPORTANT ANNOUNCEMENT

TO ALL ACTIVE AND RETIRED CARPENTERS ENROLLED IN HOMETOWN HEALTH HMO:

This is to inform you of the following change to the Hometown Health HMO Plan. Please read this announcement carefully and keep it with your Summary Plan Description booklet.

As of October 1, 2008, outpatient prescription drug coverage will no longer be provided through Hometown Health (Catalyst). Instead, prescription drug coverage for all active and retired carpenters and their eligible dependents (including COBRA participants) enrolled in the Hometown Health HMO option will be provided through Medco Health Solutions, Inc. You will find that this change means an enhancement of your prescription drug benefit. Medco has an extensive network of retail pharmacies, including all major chains, as well as a mail-order pharmacy.

- The Medco prescription drug coverage will be as follows:

Walk-In Pharmacy	<i>You pay the lower of the cost of the drug or \$10 co-pay generic, \$30 co-pay formulary brand, \$50 co-pay non-formulary brand; 30-day maximum supply</i>
Mail-Order Pharmacy	<i>You pay the lower of the cost of the drug or \$20 co-pay generic, \$60 co-pay formulary brand, \$100 co-pay non-formulary brand; 90-day maximum supply</i>

Medco will be mailing you further details on your new prescription drug coverage along with a Medco ID card and instructions on how to obtain your prescription medication. In order to have coverage, you must obtain your prescriptions through the Medco program on or after October 1, 2008. If you have an existing prescription refill on file with your mail-order pharmacy, you will need to get a new prescription from your doctor to send to Medco's mail-order pharmacy.
