SUMMARY ANNUAL REPORT

DECEMBER 31, 2024

This is a summary of the annual report for Western States Carpenters Vacation Trust, Identification Number 95-6042279 (Plan 501), for the plan year ending December 31, 2024. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

The Board of Trustees has committed itself to pay all vacation, sick leave and paid time off benefit claims incurred under the terms of the plan.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$3,536,686 as of December 31, 2024, compared to \$(106,231) as of January 1, 2024. During the plan year, the plan experienced an increase in its net assets of \$3,642,917. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$300,289,184, including employer contributions of \$293,032,577, realized gains (losses) of \$(1,344,093) from sale of assets, earnings from investments of \$8,314,324 and \$286,376 in other income.

Plan expenses were \$297,321,456. These expenses included \$291,364,690 in benefits paid to participants and beneficiaries and \$5,956,766 in administrative expenses.
